Kara pushes into classes for two lessons. One is to introduce the Zones of Regulation (the color zones) while the second lesson focuses on a toolbox to get to the green zone (learning zone). She also pushes in as needed for follow ups. She also offers a mindfulness lesson. We use the Responsive Classroom approach which is a way to talk with kids while honoring them as an individual. This helps create a positive culture and community. Primary Project: Which is a play-based program for identified students Counseling support provided as needed (focused on specific needs) Can be a formal or informal situation. Morning meeting, reset station, sensory bins, movement breaks, etc. Webinars in place for staff to help with SEL supports All members of VPS Building Council will bring their perspective of Social-Emotional Learning (SEL) to share. This year the kids and staff seem to be more on edge in general. Some teachers are working on growth mindset/mindfulness with students. Social worker part-time in our building to work in a clinical, intense format (with students with IEP's, etc.)
