## **Reviewed Survey Questions:**

Question #11: is one we should be asking. Are parents happy to receive information through google classroom or personal emails and the ECS website offering people another avenue to check(or maybe both)?

- -Parents request information regarding how this information will be sent through a stream or
- -This will be reinforced through communication teachers are having with their families due to parent teachers conferences
- -Questioned was raised about offering paper copies to families
- -Suggestion Link survey to ECS website
- -Suggestion: Could we engage parent groups to help communicate that we have the survey
- -Suggestion: Teachers use Google Classroom to receive information about electronic learning and other items about what we are doing in the classroom

Question: Do we want to focus on communications or on learning? Suggestion was made to focus a little on both because both areas are really important. This suggestion was supported by other council members

- -Keeping it succinct but speak to both issues
- -Suggestion made to create two separate surveys. Noted that we may get more responses if we only do one survey
- 1. How do you currently communicate?
- -wondered if parents might not understand how to answer. The response to the question elicits who you communicate with vs. how do you communicate. Who do you reach out to when you have questions or concerns?

Wondered what action plan will we get from this question

- 2. What resources have you used to communicate? we agreed to keep question #2
- 3. How do you prefer to receive school communication?
  - a. Google Classroom only
  - b. Google Classroom and personal emails?
- 4. What suggestions do you have for streamlining communications from ECS (administration communication; updates from classroom teachers; upcoming events
  - a. For when to expect emails
  - b. For when students have new work
- 5. What suggestions do you have for the ECS page of the VCS website to make it more user friendly. (Noted: We have control over our ECS page as opposed to the VCS website
  - Wondered if this is a good question right now
  - Discussed that this is a good question because many parents go to the website when they do not know where to look

## Parent Survey: Question Review

- We would like to elicit parent feedback on how to make it better
- Discussed how we could use this page to improve communications and provide a central place for parents to look for informations
- Add: Please list additional resources you would like to see on the page
- -Agreed to leave open ended question with an option to skip the question
- 6. How often do you want to be able to provide feedback? What format would you like to use to provide feedback on how to improve the ECS
- 7. What venues do you want to be able to provide feedback in? –questioned if this is this right order for question 15 and 16
  - Agreed to reconsider using this question
  - Discussed whether question is important
  - Would you like more information to provide the ECS with feedbackthen provide options in multiple choice format
  - Consider asking a new question: How comfortable are families with providing feedback or asking questions
  - We agreed to put this question on hold right now
- 8. Learning at home: agreed to keep current questions Suggested adding special ed service questions
  - Discussed questions about workload- and agreed that this may elicit information we cannot change
  - Discussed asking question about how students are affected by workload
  - Discussed asking for feedback about family dynamics and how students are accessing their education
